# STATEMENT OF INTENT

The Sovereign Men and Women of the Free and Independent Nation=State of OREGON have decided to remedy the abuse of power by the government of OREGON by exercising their right to form a De Jure Government as provided for in United States Constitution Article IV Sections 3 and Section 4 and upheld in the US Supreme Court by the Supreme Court decision in 1901 (Downes v. Bidwell).

***“We are determined to live under a State Government in the Republic for the United States of America and under the Constitution for the United States” and under the Declaration of Independence, cir.1776. and the OREGON Declaration of Independence, cir. 2010, ratified on November 12<sup>th</sup>, 2022, states:***

***“Whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government...”***

***“When a long train of abuses and usurpations...” and acts to seize and hold the people’s power without legal authority and “...pursuing invariably the same Object evinces (that clearly demonstrates) a design to reduce them under absolute Despotism, IT IS THEIR RIGHT, IT IS THEIR DUTY, to throw off such Government, and to provide new Guards for their future security.”***

The history of the present Governor and Government of OREGON is a history of repeated injuries and usurpations, all having in direct object the establishment of a Tyranny over the Counties of OREGON and the FREE AND INDEPENDENT NATION=STATE OF OREGON.

## **Preamble of the Free and Independent Nation=State of OREGON Constitution states:**

We, the representatives of the undersigned Counties within the State of OREGON, a Free and Independent Nation=State, ***do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....***

## **First Amendment of the United States Constitution states:**

***“Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”***

## **Fourth Amendment of the United States Constitution states:**

***“The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.”***

# STATE OF OREGON DECLARATION OF TRUTH WE THE PEOPLE

The people of OREGON are suffering from a tyrannical state government which fails to provide a republic form of governance, enables and supports across its borders the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Sovereign Men and Women of America all caused by a government of and for a mono-party system led by a tyrannical pusillanimous dictator who openly defies Federal law.

A **pusillanimous** Governor, a spineless governor who has shown a lack of courage and shrinking from their sworn oath and responsibilities for the benefit and well-being of the free and sovereign Men and Women of the Free and Independent Nation=State of Oregon, whose character is thus marked by every act which may define a tyrant, is unfit to be the elected Governor of a free people. Likewise, the Elected, Appointed and Regional Officials of the State of OREGON including the many unlawful departments of the corporation government who have grossly usurped authority and actively and grievously committed atrocities against We the People, such as, but not limited to, the DEQ, the unconstitutional sheriffs, the Department of Health and Welfare, the Child Services Department, The Bureau of Land Management, and the state and federal Forestry Departments, the AMA, CDC, and FDA whose character is thus marked by every act which may define them are that of a tyrant, abusive, unconstitutional and their criminal and despicable acts as corrupt authorities, are unfit to be the Elected, Appointed and deemed Regional Officials of a free people.

Governors and Officials of the State of OREGON have exhibited evidence of Tyranny and Treason against the Sovereign Men and Women, Counties, Towns and Cities of the State of OREGON.

The history of the present **pusillanimous** Governor of OREGON, the past Globalist Governor of OREGON, and many other Officials of the various unlawful departments of the State and county governments of OREGON have historically and repeatedly caused injuries and usurpations upon the sovereign Men and Women of Oregon, revealing their corrupt agenda and ultimate goal of establishing an absolute tyrannical government over the State of OREGON are thus guilty of treason, a crime punishable by death. They are desperate to hide their complicity, and thus they systematically target, demonize, and even “suicide” all who threaten to expose their treachery and malfeasance.

We the sovereign Men and Women of the Free and Independent Nation=State of OREGON have Petitioned for Redress of Grievances in the most humble terms. Reading a total of one hundred ninety Grievances at County Courthouse locations within the borders of OREGON State during the course of the year of 2023. Nor have we, the sovereign Men and Women of the Free and Independent Nation=State of OREGON, been wanting in attentions to our OREGON brethren, but our repeated Petitions have been answered only by repeated injury.

## **OREGON STATE VIOLATES:**

### **United States Constitution Article IV Section 4**

**“The United States shall guarantee to every State in this Union a Republican Form of Government** and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence.”

### **United States Constitution Article VI**

“This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.”

### **First Amendment, United States Constitution**

“Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”

### **Fourteenth Amendment, United States Constitution Section 3.**

“No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution for the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.”

# WE THE PEOPLE

The State of OREGON is in constitutional default and does not have constitutional standing as a member state in the union of states called the United States of America. We the People, as Sovereign Men and Women of the United States living in the Free and Independent Nation=State of OREGON, are following the process of West Virginia, which successfully restored the Virginia state government after the Wheeling Conventions of 1861. Congress admitted OREGON into the Compact of Statehood within the United States of America in 1859 because their 1857 Constitution, ratified for consideration, guaranteed a republic form of government.

The exclusion of We The People from the legislature and the legislative process in OREGON has long been one of concern to OREGONIANS. As each year goes by, the overbalance of the bureaucracies' influence in all elements of the legislative process has created a bureaucratic state that has drowned out the voices of the very People the servants are to serve.

Perhaps there is no better explanation of the exclusion of the People than from looking at different incidences and issues that have occurred in our legislature.

Story: EPOCH Times: "Oregon Governor wants to take authority over the State's Public Defender Agency. Senate Bill 337 to move a judicial agency to being under full control of the Executive Branch. Tina Kotek makes a grab to control the judicial branch by the Executive branch. (No intent on corruption there?) Jon Mosher, deputy director of the Sixth Amendment Center, told Oregon lawmakers at a May 11 informational hearing that U.S. Supreme Court case law calls for public defense to be independent of government interference."

LC 1681/Bill 2493 - An Attack On Our Freedom Of Religion  
Representative Salinas, Chair of the House Committees on Health Care and Behavioral Health created a work group in the spring of 2020 under the guise of creating a "Registry" for all "Alternative Medicine Practitioners" who are exempt from licensing or where no licensing is provided for within the State of Oregon. Along with co-author, Representative Moore-Green, they created "LC 1681". This is a proposed bill that will not only destroy all forms of Alternative medicine in the state but embedded within the language of this proposed bill are stipulations and requirements that is nothing short of an unprecedented attack on the freedoms of the Church. Alternative Medical Practitioner (includes all forms of "well-being care" which would include all ministries of the church)

At a glance this appears to target all fields of Alternative, Complimentary and Holistic Medical fields. However, all ministerial functions are included under this and other titles. The latest statistics show that between 40 - 45% of people in Oregon are choosing these fields of care for dealing with their health issues over traditional Medicine. AARP reports that over 70% in age groups 50 and over choose alternative medical care over traditional medicine. This is a threat to the American Medical Assoc. and big Pharma. Salinas and Moore-Green would do away with all forms of alternative medicine in the state.

"Well-being care" (pg. 1:2) - Any and all forms of practices that affect a person's wellbeing. This includes any practice that *affects a person or group of people's personal growth, emotions, attitude, relationships, or life - physically, philosophically, emotionally, socially, and SPIRITUALLY* (pg. 3:1-10). Spiritual based disciplines are listed on pg. 3:5. This would include ALL ministries and outreaches of any kind. But there is more! THIS LITERALLY COULD AFFECT EVERY PARENT RAISING THEIR CHILDREN OR ANY PERSON GIVING SPIRITUAL, MORAL OR JUST PRACTICAL GUIDANCE OR OPINION TO SOMEONE ELSE.

**Oversight Entity** (pg. 2:12) This proposed Bill would establish a 3rd party (pg. 4:13-14) with oversight and regulatory powers (pg. 8:17-18; 10:16) to oversee, regulate, monitor, describe and define duties and responsibilities and have the power to modify the rules and standards "as they see fit" (pg. 7:25). (Uninformed and uneducated people – agents of the government telling people how to do what they have been trained and educated to do. Is this in any way a bit of Government over-reach? How about telling pastor/ministers how to preach and what they can or cannot teach, preach, or minister or what you can sing or channel or meditate. All will be accountable to this entity (pg. 2:14-15). This entity also would handle complaints (pg. 2:18-22) with the regulatory power to discipline with punitive damages and rights to revoke privileges (pg. 7:1-5). Watch you don't offend anyone! This entity will also develop tutorials and training on how they regulate you (pg. 7:12-13).

Voluntary Oversight Registry (pg. 2:16-22; Sect. 2 - pg. 3:23) Licensing Office has the authority to establish application and renewal fees (pg. 7:11) required for a "Voluntary" Registration of anyone who DEALS IN ANY WAY with a person's emotions, feelings, attitude, or life as described above. Penalties will be charged for failure to register and maintain your registration. NOT VOLUNTARY!

These are just two examples.

“The worst abuses of executive branches—plural—is emergency authority, declarations of emergency, and the ability of the governor to usurp the power and center it more in the executive branch of government. That’s exactly what’s happened. That cuts the Legislature out. And that’s all purposely done.”

#### **United States Constitution Article IV, Section 4.**

Protection of States Guaranteed Republic Form of Government **"The United States shall guarantee to every state in this union a republican form of government...."**

The Founding Fathers (Framers) made it clear a republic form of government was the only government for the United States. *"When the representative body have lost the confidence of their constituents, when they have notoriously made sale of their most valuable rights, when they have assumed to themselves powers which the people never put into their hands, then indeed their continuing in office becomes dangerous to the state" ~ Thomas Jefferson*
