STATEMENT OF INTENT

The Sovereign Men and Women of the Free and Independent Nation=State of OREGON have decided to remedy the abuse of power by the government of OREGON by exercising their right to form a De Jure Government as provided for in the United States Constitution Article IV Sections 3 and Section 4 and upheld in the US Supreme Court by the Supreme Court decision in 1901 (Downes v. Bidwell).

“We are determined to live under a State Government in the Republic for the United States of America and under the Constitution for the United States” and under the Declaration of Independence, cir.1776. and the OREGON Declaration of Independence, cir. 2010, ratified on November 12th, 2022, states:

“Whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government...”

“When a long train of abuses and usurpations...” and acts to seize and hold the people’s power without legal authority and “...pursuing invariably the same Object evinces (that clearly demonstrates) a design to reduce them under absolute Despotism, IT IS THEIR RIGHT, IT IS THEIR DUTY, to throw off such Government, and to provide new Guards for their future security.”

The history of the present Governor and Government of OREGON is a history of repeated injuries and usurpations, all having in direct object the establishment of a Tyranny over the Counties of OREGON and the FREE AND INDEPENDENT NATION=STATE OF OREGON.

Preamble of the Free and Independent Nation=State of OREGON Constitution states:

We, the representatives of the undersigned Counties within the State of OREGON, a Free and Independent Nation=State, ***do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....***

First Amendment of the United States Constitution states:

“Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”

Fourth Amendment of the United States Constitution states:

“The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.”

TYRANNY EXISTS IN OREGON

The people of OREGON are suffering from a tyrannical state government which fails to provide a republic form of governance, enables and supports across its borders the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Sovereign Men and Women of America all caused by a government of and for a mono-party system led by a tyrannical pusillanimous dictator who openly defies Federal law.

OREGON STATE VIOLATES:

United States Constitution Article IV Section 4

“The United States shall guarantee to every State in this Union a Republican Form of Government and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence.”

United States Constitution Article VI

“This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.”

First Amendment, United States Constitution

“Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”

Fourteenth Amendment, United States Constitution Section 3.

“No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution for the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.”

DECLARATION OF TYRANNY

Violation of United States Constitution Article IV Section 4, Clause 1

“The United States shall guarantee to every state in this union a republic form of government.....”

Today, Oregon is in a state of free fall at all levels. This free fall has been orchestrated over the last 170 years by socialist and communist regimes and we're now nearing the end of their socialist/communist plan that clearly demonstrates a design to reduce United States Sovereign Men and Women living in OREGON under absolute Despotism. Today this plan has eliminated the three branches of government, created a mono-party legislature which has enabled and empowered the rise of a **pusillanimous** Governor turned dictator.

A **pusillanimous** Governor, a spineless governor who has shown a lack of courage and shrinking from their sworn oath and responsibilities for the benefit and well-being of the free and sovereign Men and Women of the Free and Independent Nation=State of Oregon. Whose character is thus marked by every act which may define a tyrant, is unfit to be the elected Governor of a free people. Likewise, the Elected, Appointed and Regional Officials of the State of OREGON including the many unlawful departments of the corporation government who have grossly usurped authority and actively and grievously committed atrocities against We the People, such as, but not limited to, the DEQ, the unconstitutional sheriffs, the Department of Health and Welfare, the Child Services Department, The Bureau of Land Management, and the state and federal Forestry Departments, the AMA, CDC, and FDA whose character is thus marked by every act which may define them are that of a tyrant, abusive, unconstitutional and their criminal and despicable acts as corrupt authorities, are unfit to be the Elected, Appointed and deemed Regional Officials of a free people.

Governors and Officials of the State of OREGON have exhibited evidence of Tyranny and Treason against the Sovereign Men and Women, Counties, Towns and Cities of the State of OREGON.

The history of the present **pusillanimous** Governor of OREGON, the past Globalist Governor of OREGON, and many other Officials of the various unlawful departments of the State and county governments of OREGON have historically and repeatedly caused injuries and usurpations upon the sovereign Men and Women of Oregon, revealing their corrupt agenda and ultimate goal of establishing an absolute tyrannical government over the State of OREGON are thus guilty of treason, a crime punishable by death. They are desperate to hide their complicity, and thus they systematically target, demonize, and even “suicide” all who threaten to expose their treachery and malfeasance.

We, the sovereign Men and Women of the Free and Independent Nation=State of OREGON have Petitioned for Redress of Grievances in the most humble terms. A total of one hundred ninety Grievances were read at County Courthouse locations within the borders of OREGON State during the course of the year of 2023. Nor have we, the sovereign Men and Women of the Free and Independent Nation=State of OREGON, been wanting in attentions to our OREGON brethren, but our repeated Petitions have been answered only by repeated injury.

As our Founding Fathers debated our Constitution, they took instruction from the history they knew. Concerned that the democratic republic they envisioned would collapse, they contemplated the descent of ancient democracies and republics into oligarchy and empire. As they knew, Aristotle warned that inequality brought instability, while Plato believed that demagogues exploited free speech to install themselves as *tyrants*. In founding a Republic upon law and establishing a system of checks and balances, the Founding Fathers sought to avoid the evil that they, like the ancient philosophers, called tyranny. They had in mind the usurpation of power by a single individual or group, or the circumvention of law by rulers for their own benefit.

It is thus a primary American tradition to consider history when our political order seems imperiled. If we worry today that the American experiment is threatened by tyranny, we can follow the example of the Founding Fathers and contemplate the history of other democracies and republics. The history of modern democracy that has been pushed upon us is one of decline and fall. Democracies collapsed into authoritarianism and fascism. Both fascism and communism were responses to globalization: to the real and perceived inequalities it created, and the apparent helplessness of the democracies in addressing them. Fascists and Communists reject reason in the name of will, denying objective truth in favor of a glorious myth articulated by leaders who claimed to give voice to the people when only the opposite has been true. They proposed rule by a select disciplined party elite with a monopoly on reason and censorship of free speech and truth that would guide society toward a certain future according to supposedly fixed laws which only push their agenda, enslave the masses, and enrich a select few. This is, by all definition, TYRANNY.

Since the American colonies declared their independence from a British monarchy that the Founders deemed “tyrannical,” European history has seen three major democratic moments: after the First World War in 1918, after the Second World War in 1945, and after the end of communism in 1989. Many of the democracies founded at these junctures failed, in circumstances that in important respects resemble our own present perverted and abusive government.

For the signers of the Declaration of Independence, “liberty” is the universal notion that every person should determine their own path to happiness free from undue government control. Patrick Henry preferred death to living without it. John Adams risked his reputation by defending in court the British soldiers involved in the Boston Massacre, recounting years later that a defense lawyer ought to be the last thing a person should be without in a free country.

In fact, “liberty” is so central to the American Ideals that the Framers of our Constitution (Delegates from the Assemblies of each of the 13 colonies) created a Bill of Rights to protect personal liberty from the tyranny of big government. All people, they argued, should be free to express unpopular opinions or choose one’s own religion or protect one’s home without fear of retaliation from the state. Those same colonies became the original thirteen states of the United States of America.

Preeminent in the Bill of Rights is the idea that no one’s liberty can ever be taken away without the process being fair. A jury made up of their peers (everyday men and women), protections against self-incrimination, being informed of the nature of the offense for which one is accused, and the right to a speedy and public trial are all American ideals of justice. And so all of them were enshrined in the first ten amendments to the United States Constitution, which became law when they were ratified by the states in 1791.

The Assembly Representatives of this new Republic had created a new federal government to administer the union of their respective state governments. They were well acquainted with England’s history of government abuse in which people were subjected to unfair methods of prosecution and investigation and left with no personal protections. Having just liberated the Colonies from what they felt was the tyrannical rule of the British government, the Framers of our Constitution were unwilling to create a new tyranny in the form of this Union’s central government that could ignore, or worse, could abolish these protections of personal liberty.

As Thomas Jefferson wrote in 1787, “A bill of rights is what the people are entitled to against every government on earth, general or particular, and what no just government should refuse.” We, the people, have just enshrined these rights so you, the government, cannot take them away from us. And so, with the passage of the Bill of Rights, the rights of WE THE PEOPLE are held to be too important and valuable to be interfered with. The government is obligated to enforce them for all mankind, for all time.

Thomas Jefferson, in Our Declaration of Independence, clearly and poignantly wrote, “When, in the course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth the separate and equal station to which the laws of nature and of nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.”

Today, we face an enemy, both foreign and domestic, that would destroy our foundational statutes and remove our fundamental rights and freedoms. We, the people of the Free and Independent Nation=State of OREGON, stand and declare that, in accordance with the Declaration of Independence, *“When a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, **it is their right, it is their duty**, to throw off such Government, and to provide new Guards for their future security.”*

Our present and previous corrupt Governor and state officials have destroyed OREGON’s economy, ripped families apart, and cast a questionable shadow on the future of a once promising state, controlled major newspapers and news services, enabling them to shape what is reported and how it is framed, misinformed, divided people over ethnicity, gender, sexual orientation, religion, and economic class. They have slandered and destroyed the honorable reputations of anyone who exposed them, destroyed the value of our currency, and bankrupted our nation. By their devious actions, they have pursued the end of nationalism, patriotism, private property, individual rights, the two-parent family, automobiles, air travel, and the right to defend ourselves from a tyrannical government. They have worked to subvert our great state of OREGON and silence anyone in opposition or who stands in the way of their totalitarianism and oppressive rule deeming them unstable and a danger to society. They have enriched themselves at the cost of impoverishing the people. Through their skewed statistics, deceptive polls, false facts, and the omission of decisive information, they have subverted our election process and disenfranchised the voters with their fraudulent schemes. They promote disdain for state and country, dependency on government, indulgence, lawlessness, and immorality, to spoil and dishearten the people. They have perpetrated inhumane acts of sickening and destroying lives through fluorination, untested, experimental drugs that they illegally and unlawfully called “vaccines” and fraudulently represented them as cures. They have deployed technologies, to cause harm to the people, that were used to pollute our air, our water, and our food supplies in order to subjugate the people and create the people’s dependency on harmful drugs. Through their vast indoctrination machine, they have convinced THE PEOPLE that America is a Democracy, and that Democracy is the highest form of government. This is problematic because Democracy is by definition, “mob rule.” Democracies invariably fail because “the majority mob”, historically always has crumbled into economic ruin and the proof of their failure is clearly evidenced in our present failing economy. The word Democracy does not appear anywhere in the America’s founding documents, because our Forefathers knew that Democracy, in any form or disguise, is fatally flawed, leading invariably to oppression, unrest, societal failure, violence, death and puts the people under tyrannical oppression.

Article IV. Section 4 of the U.S. Constitution resolves any doubt, “The United States shall guarantee to every State in this Union a Republican Form of Government”.

The people of the Free and Independent Nation=State of OREGON are rightful owners of our land, our labor, our well-being, our future, and our children, for our benefit, and the benefit of our posterity.

We entreat a bloodless solution, wherein you cease all destruction activities, dissolve your unlawful and unconstitutional tyrannical rule and other illicit legal structures and custodial instruments, return our land, our assets, and our De Jure government to We The People, retire, withdrawing your influence in an orderly fashion, so the people of OREGON can once again pursue our God-given rights of Life, Liberty and the Pursuit of Happiness.

Let it be known to all the world that OREGON State and the Free and Independent Nation=State of OREGON are resolute in our posture and positions. We declare that we are not the properties, not the administrative state, not the province of any theocratic ruler, nor any monarch, nor foreign entity or government but is a FREE AND INDEPENDENT NATION=STATE in the REPUBLIC for the United States of America.

OREGONIANS stand united to follow the United States Constitution Article IV, Sections 3 and 4 to throw off the tyranny that has been foisted upon all Sovereign Men and Women of the United States.

We, the sovereign Men and Women of the Free and Independent Nation=State of Oregon and the sovereign Counties that lie within, united by our United States Constitution, declare that we are a sovereign State and “this nation, under God, shall have a new birth of freedom, and that government of the people, by the people, for the people, shall not perish from the earth.”

ACTS OF INSURRECTION

The government of OREGON, the current socialist governor/dictator and mono-party system along with local officials are following a coordinated design with the intent to actively engage in “*Acts of Insurrection*” against the United States Constitution.
