DECLARATION OF CONTROLL

SEPTEMBER 9, 2023

### STATEMENT OF INTENT

The Sovereign Men and Women of the Free and Independent Nation=State of OREGON have decided to remedy the abuse of power by the government of OREGON by exercising their right to form a De Jure Government as provided for in United States Constitution Article IV Sections 3 and Section 4 and upheld in the US Supreme Court by the Supreme Court decision in 1901 (Downes v. Bidwell).

"We are determined to live under a State Government in the Republic for the United States of America and under the Constitution for the United States" and under the Declaration of Independence, cir. 1776. and the OREGON Declaration of Independence, cir. 2010, ratified on November 12<sup>th</sup>, 2022, states:

"Whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government..."

"When a long train of abuses and usurpations..." and acts to seize and hold the people's power without legal authority and "...pursuing invariably the same Object evinces (that clearly demonstrates) a design to reduce them under absolute Despotism, <u>IT IS THEIR</u>

<u>RIGHT, IT IS THEIR DUTY,</u> to throw off such Government, and to provide new Guards for their future security."

The history of the present Governor and Government of OREGON is a history of repeated injuries and usurpations, all having in direct object the establishment of a Tyranny over the Counties of OREGON and the FREE AND INDEPENDENT NATION=STATE OF OREGON.

### Preamble of the Free and Independent Nation=State of OREGON Constitution states:

We, the representatives of the undersigned Counties within the State of OREGON, a Free and Independent Nation=State, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

### First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

### **Fourth Amendment of the United States Constitution states:**

"The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized."

# STATE OF OREGON OREGON DECLARATION OF TRUTH EMERGENCY ORDINANCE

The people of OREGON are suffering from a tyrannical state government which fails to provide a republic form of governance, enables and supports across its borders the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Sovereign Men and Women of America all caused by a government of and for a mono-party system led by a tyrannical pusillanimous dictator who openly defies Federal law.

A **pusillanimous** Governor, a spineless governor who has shown a lack of courage and shrinking from their sworn oath and responsibilities for the benefit and well-being of the free and sovereign Men and Women of the Free and Independent Nation=State of Oregon. Whose character is thus marked by every act which may define a tyrant, is unfit to be the elected Governor of a free people. Likewise, the Elected, Appointed and Regional Officials of the State of OREGON including the many unlawful departments of the corporation government who have grossly usurped authority and actively and grievously committed atrocities against We the People, such as, but not limited to, the DEQ, the unconstitutional sheriffs, the Department of Health and Welfare, the Child Services Department, The Bureau of Land Management, and the state and federal Forestry Departments, the AMA, CDC, and FDA whose character is thus marked by every act which may define them are that of a tyrant, abusive, unconstitutional and their criminal and despicable acts as corrupt authorities, are unfit to be the Elected, Appointed and deemed Regional Officials of a free people.

Governors and Officials of the State of OREGON have exhibited evidence of Tyranny and Treason against the Sovereign Men and Women, Counties, Towns and Cities of the State of OREGON.

The history of the present **pusillanimous** Governor of OREGON, the past Globalist Governor of OREGON, and many other Officials of the various unlawful departments of the State and county governments of OREGON have historically and repeatedly caused injuries and usurpations upon the sovereign Men and Women of Oregon, revealing their corrupt agenda and ultimate goal of establishing an absolute tyrannical government over the State of OREGON are thus guilty of treason, a crime punishable by death. They are desperate to hide their complicity, and thus they systematically target, demonize, and even "suicide" all who threaten to expose their treachery and malfeasance.

We the sovereign Men and Women of the Free and Independent Nation=State of OREGON have Petitioned for Redress of Grievances in the most humble terms. Reading a total of one hundred ninety Grievances at County Courthouse locations within the borders of OREGON State during the course of the year of 2023. Nor have we, the sovereign Men and Women of the Free and Independent Nation=State of OREGON, been wanting in attentions to our OREGON brethren, but our repeated Petitions have been answered only by repeated injury.

### **OREGON STATE VIOLATES:**

### **United States Constitution Article IV Section 4**

"The United States shall guarantee to every State in this Union a Republican Form of Government and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence."

### **United States Constitution Article VI**

"This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding."

### First Amendment, United States Constitution

"Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

### Fourteenth Amendment, United States Constitution Section 3.

"No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution for the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability."

## EMERGENCY ORDINANCE

The evidence is now clear that patterns and acts of **DISLOYALTY** are on full display daily against **We the People of OREGON**, **A Free and Independent Nation=State**, and **We the People of the United States**. Not only on the federal level but on the state and local level as well from City Council, County Board of Supervisors, and School Boards which have all become hot beds of open seditious disloyalty against all of their constituents and the Constitution for the United States.

## AN EMERGENCY ORDINANCE FOR THE REORGANIZATION OF THE FREE AND INDEPENDENT NATION=STATE OF OREGON GOVERNMENT

We the People, of the Free and Independent Nation=State of OREGON, by their Delegates assembled in the Oregon General Jural Assembly do ordain as follows:

A Chief Justice and Moderator and following, a Governor, Lieutenant Governor, Attorney General, and Secretary of State for the Free and Independent Nation=State of OREGON shall be appointed by this body to discharge the duties and exercise the powers which pertain to their respective offices by the existing laws of the State under the Constitution of 1857 as approved by the United States Congress at the time of statehood, and to continue in office for a one year term according to the Covenant of Oregon, or until their successors be elected and qualified. The General Assembly is, by law, required to provide for an election of Governor and Lieutenant Governor by the sovereign Men and Women of the Free and Independent Nation=State of Oregon. This election is to be accomplished as soon as such an election can be properly held.

A Council, to consist of five members, shall be appointed by the Delegates assembled, to consult with and advise the Governor, respecting such matters pertaining to his/her official duties as he/she shall submit for consideration, and to aid in the execution of his/her official orders. Their term of office shall expire at the same time as that of the Governor.

We, the sovereign Men and Women, of the Free and Independent Nation=State of OREGON, cannot rely upon a lawful and just election system in the State of OREGON which is supported by overwhelming evidence of fraudulent elections that has destroyed our Republic form of government. To be sure, the OREGON State Legislature, whose duty it is to legislate and ensure and conduct free and fair elections, has worked in conjunction with the State Executive and instituted wherever their usurped power extends, a reign of terror intended to suppress the free expression of the **Will of the People**, making elections a mockery and a fraud. The evidence of disloyalty to the Constitution for the United States is obvious. Therefore, the OREGON State Legislature has no constitutional authority to conduct negotiations with We the People of the Free and Independent Nation=State of OREGON.

Therefore, the disloyal Legislature, Executive, and Judiciary have shown clear and convincing evidence to We the People of the Free and Independent Nation=State of OREGON of their vacating and abandoning their fraudulently elected and appointed offices. This is evidence of abdication of their responsibilities of authority and sovereignty over the free and sovereign Men and Women of the United States living in OREGON State. Thus, the OREGON Legislature, Executive and Judiciary have been committing acts of insurrection and secession against the Constitution for the United States, all of the States in the Union of States, and all free and sovereign Men and Women of the United States.

Therefore, those previously fraudulently elected to the disloyal OREGON Legislature, Assembly and Senate under the OREGON State Constitution of 1857 and all subsequent amendments and propositions are to be deemed disqualified from office effective November 12<sup>th</sup>, 2022. Consistent with the We the People of the Free and Independent Nation=State of OREGON Notice: **Declaration of Constitutional Default** issued on November 12<sup>th</sup>, 2022, those disloyal elected and appointed to the Executive and Judiciary branches are to be deemed disqualified from office effective November 12<sup>th</sup>, 2022.

Constitutional restrictions make it necessary for the formation of a government of OREGON to be loyal to the United States Constitution and the Union of States as proclaimed by compact by the United States Congress on September 9, 1850. Therefore, a legislature whose unquestioned loyalty to the United States Constitution and to the Union of States is the only legislature who could then give permission for the creation of a new state government.

New Assembly Members and Senators appointed to the Legislature of the Restored Government shall qualify themselves by taking the oath or affirmation hereinafter set forth and shall constitute the Legislature of the State. They shall discharge the duties and exercise the powers pertaining to the General Assembly. They shall hold their offices from the passage of this Ordinance until the end of the terms for which they were respectively appointed. They shall assemble and proceed to organize themselves as prescribed by existing laws in their respective branches. A majority in each branch of the members qualified as aforesaid shall constitute a quorum to do business. A majority of the members of each branch thus qualified, voting affirmatively, shall be competent to pass any act deemed necessary, provided they are consistent with the Constitution for the United States.

The appointed Governor, Lieutenant Governor, Attorney General, Secretary of State, members of the Legislature, and all officers now in the service of the State, or of any county, city or town thereof, or hereafter to be elected or appointed for such service, including the judges and clerks of the several courts, sheriffs, commissioners of the revenue, justices of the peace, officers of the city and municipal corporations, and officers of militia, and officers and privates of volunteer companies of the State, not mustered into the service of the United States, shall each take the following oath or affirmation before proceeding in the discharge of their several duties:

"I solemnly swear (or affirm) that I will support the Constitution for the United States, the Declaration of Independence and the laws made in pursuance thereof, as the supreme law of the land, anything in the Constitution for the Restored Government of the Free and Independent Nation=State of OREGON to the contrary notwithstanding, and that I will uphold and defend the Restored Government of the Free and Independent Nation=State of OREGON, so help me God."

If any elective officer, who is required by the preceding section to take such oath or affirmation, fail or refuse to do so, it shall be the duty of the Governor, upon satisfactory evidence of the fact, to issue his/her writ declaring the office to be vacant, and providing for a special election to fill such vacancy at some convenient and early day to be designated in said writ, of which due publication shall be made for the information of the persons entitled to vote at such election, and such writ may be directed, at the discretion of the Governor, to the sheriff or sheriffs of the proper county or counties, or to a special commissioner or commissioners to be named by the Governor for the purpose. If the officer who fails or refuses to take such oath or affirmation be appointed by the Governor, he/she shall fill the vacancy without writ, but if such officer be appointed otherwise than by the Governor or by election, the writ shall be issued by the Governor, directed to the appointing power, requiring it to fill the vacancy.

## For those who don't understand the United States Constitution the "Government" is "We the People".

We entreat a bloodless solution, wherein you cease all destruction activities, dissolve your unlawful and unconstitutional tyrannical rule and other illicit legal structures and custodial instruments, return our land, our assets, and our De Jure government to We The People, retire, withdrawing your influence in an orderly fashion, so the people of OREGON can once again pursue our God-given rights of Life, Liberty and the Pursuit of Happiness.

In OREGON, A Free and Independent Nation=State, we echo the thoughts, convictions, principles, and ideals of the Founders of the United States of America.
