#### STATEMENT OF INTENT

The Sovereign Men and Women of the Free and Independent Nation=State of OREGON have decided to remedy the abuse of power by the government of OREGON by exercising their right to form a De Jure Government as provided for in United States Constitution Article IV Sections 3 and Section 4 and upheld in the US Supreme Court by the Supreme Court decision in 1901 (Downes v. Bidwell).

"We are determined to live under a State Government in the Republic for the United States of America and under the Constitution for the United States" and under the Declaration of Independence, cir. 1776. and the OREGON Declaration of Independence, cir. 2010, ratified on November 12<sup>th</sup>, 2022, states:

"Whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government..."

"When a long train of abuses and usurpations..." and acts to seize and hold the people's power without legal authority and "...pursuing invariably the same Object evinces (that clearly demonstrates) a design to reduce them under absolute Despotism, <u>IT IS THEIR</u>

<u>RIGHT, IT IS THEIR DUTY</u>, to throw off such Government, and to provide new Guards for their future security."

The history of the present Governor and Government of OREGON is a history of repeated injuries and usurpations, all having in direct object the establishment of a Tyranny over the Counties of OREGON and the FREE AND INDEPENDENT NATION=STATE OF OREGON.

#### Preamble of the Free and Independent Nation=State of OREGON Constitution states:

We, the representatives of the undersigned Counties within the State of OREGON, a Free and Independent Nation=State, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

#### First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

#### **Fourth Amendment of the United States Constitution states:**

"The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized."

The people of OREGON are suffering from a tyrannical state government which fails to provide a republic form of governance, enables and supports across its borders the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Sovereign Men and Women of America all caused by a government of and for a mono-party system led by a tyrannical pusillanimous dictator who openly defies Federal law.

A pusillanimous Governor, a spineless governor who has shown a lack of courage and shrinking from their sworn oath and responsibilities for the benefit and well-being of the free and sovereign Men and Women of the Free and Independent Nation=State of Oregon, whose character is thus marked by every act which may define a tyrant, is unfit to be the elected Governor of a free people. Likewise, the Elected, Appointed and Regional Officials of the State of OREGON including the many unlawful departments of the corporation government who have grossly usurped authority and actively and grievously committed atrocities against We the People, such as, but not limited to, the DEQ, the unconstitutional sheriffs, the Department of Health and Welfare, the Child Services Department, The Bureau of Land Management, and the state and federal Forestry Departments, the AMA, CDC, and FDA whose character is thus marked by every act which may define them are that of a tyrant, abusive, unconstitutional and their criminal and despicable acts as corrupt authorities, are unfit to be the Elected, Appointed and deemed Regional Officials of a free people.

Governors and Officials of the State of OREGON have exhibited evidence of Tyranny and Treason against the Sovereign Men and Women, Counties, Towns and Cities of the State of OREGON.

The history of the present **pusillanimous** Governor of OREGON, the past Globalist Governor of OREGON, and many other Officials of the various unlawful departments of the State and county governments of OREGON have historically and repeatedly caused injuries and usurpations upon the sovereign Men and Women of Oregon, revealing their corrupt agenda and ultimate goal of establishing an absolute tyrannical government over the State of OREGON are thus guilty of treason, a crime punishable by death. They are desperate to hide their complicity, and thus they systematically target, demonize, and even "suicide" all who threaten to expose their treachery and malfeasance.

We the sovereign Men and Women of the Free and Independent Nation=State of OREGON have Petitioned for Redress of Grievances in the most humble terms. Reading a total of one hundred ninety Grievances at County Courthouse locations within the borders of OREGON State during the course of the year of 2023. Nor have we, the sovereign Men and Women of the Free and Independent Nation=State of OREGON, been wanting in attentions to our OREGON brethren, but our repeated Petitions have been answered only by repeated injury.

#### **OREGON STATE VIOLATES:**

#### **United States Constitution Article IV Section 4**

"The United States shall guarantee to every State in this Union a Republican Form of Government and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence."

#### United States Constitution Article VI

'This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.'

#### First Amendment, United States Constitution

"Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

#### Fourteenth Amendment, United States Constitution Section 3.

"No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution for the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability."

# 1 DAY – 1 VOTE

The state of OREGON is in constitutional default and does not have constitutional standing as a member state in the union of states called the United States of America. We the People as Sovereign Men and Women of the United States living in the Free and Independent Nation=State of OREGON are following the process of West Virginia, which successfully restored the Virginia state government after the Wheeling Conventions of 1861. Congress admitted OREGON into the Compact of Statehood within the United States of America in 1859 because their 1857 Constitution, ratified for consideration, guaranteed a republic form of government.

The Guarantee Clause imposes limitations on the type of government a state may have. The Clause requires the United States to prevent any state from imposing rule by monarchy, dictatorship, aristocracy, or permanent military rule, even through majority vote.

Instead, governing by electoral processes is constitutionally required. Of course, this limitation upon state governments also prohibits them from having pure democracies, where the majority is unrestricted by a constitution, where those who have the money, media, and other means to sway the majority can impose their collective will upon the minority by various means, such as influencing election outcomes. Yet, OREGONIANS have witnessed this type of manipulation for more than half a century.

### So, if OREGON is not a republic, then what form of government is controlling the lives of OREGONIANS?

So now the state of OREGON and most of the states from around the country have established the 2-month election "vote" cycle that saturates the state with mail in ballots by the millions more than the state has in population of registered voters, then over 60 days electronically manipulates the outcome of every race in OREGON virtually by internet connectivity working in conjunction with foreign countries.

The result: massive fraud and disenfranchisement being reported from all counties around the state. While there is massive voter fraud and disenfranchisement being reported by the Sovereign Men and Women those government officials benefiting most from the very fraud they are committing against the Sovereign Men and Women claim there is "nothing to see here" as they stay in power and benefit from their crimes.

While OREGON takes months to count ballots, Florida and Texas take a single day, 1 DAY. And it's not just Florida and Texas: nearly every other state is also done counting. As a result, the nation's entire balance of power remains uncertain because OREGON fails to release the election outcomes for weeks after "election" day.

The security, authenticity, validity, and effectiveness of legitimate voters of every city, county and state is a fundamental expression of their First Amendment rights and as such is guaranteed equal protection under our United States Constitution.

Absolute protection of voter rights and the execution of the election process is a duty of local and state government officials, who by their sworn oaths of office and our Constitution, are under obligation to be vigilant of state and county election fraud and therefore, the security and safety of the entire election process, from start to completion must be of the highest order of priority.

Unfortunately, the reality is that our state and county officials have consistently demonstrated a profound lack of duty, responsibility, and obligation for the investigation of glaring election anomalies and complaints and have failed to alleviate the negative impact of these anomalies and complaints which have eroded and destroyed the confidence of the Oregon voters.

The maintenance of confidence in this one citizen, **1 DAY - 1 VOTE** system is the duty of all government election officials and agencies. The recent tsunami of election irregularities and the verifiable existence of proven voter fraud in multiple jurisdictions across the state of OREGON and United States at the hands of government agencies/officials has served to create a crisis of confidence in our election process being indeed safe and secure and that state and local governments have failed in their duty to address these issues in an open, fair, transparent, and Constitutional manner.

We, the sovereign People of the Free and Independent Nation=State of OREGON, declare that we want secure, safe, free and fair elections and that though our elected county and state officials tell us that our elections are such, their words and actions are in contradiction to the evidence.

Shamefully, the very agents of the state and county governments that swear an oath to uphold the United States Constitution have encumbered, disrupted, obstructed, and out-right denied access of the people to public records, refused to investigate findings from election canvassers, and corrupted and destroyed the reputation of election integrity minded voters.

These corrupt actions and behaviors have created a separation between the government and the right of all people to be secure in their thoughts, their person, and their right to exercise free speech. This separation has usurped the authority and God-given right of a free people to be secure in their right of self-expression without fear of any level or degree of threat at the hands of the government or any government official.

These heinous actions of the government and government officials have negatively impacted voter confidence in our elections and has created a state and condition of voter disenfranchisement. In other words, it fosters an attitude of, "Why bother voting if the vote is rigged?" A reasonable question is, "If the elections are fair, why are officials fighting so hard to prevent the PEOPLE from verifying their fairness?"

In reality, every fraudulent vote cancels out a legitimate vote and the People's voice is negated for the agenda of a few elitists.

As clearly stated in the **Election Clause** of the 4<sup>th</sup> Amendment of the Constitution, the Framers of the Constitution were concerned that state governments might establish unfair election procedures or attempt to undermine the state and national elections by refusing to hold fair and secure elections. It established a single Election Day for elections, limited the amount of money that can be contributed to candidates, required full disclosure of election-related spending, mandated that voter registration be made available at various public offices and required state governments to ensure the accuracy of their voter registration. These principles are the heart of the **1 DAY – 1 VOTE** system.

The Election Clause of the 4<sup>th</sup> Amendment of the Constitution prevents any entity from enacting laws that violate these constitutional provisions. The Elections Clause does not permit either the states or Congress to override those provisions by establishing additional qualifications for voting.

Likewise, the Fourteenth Amendment to the United States Constitution protects the fundamental right to vote, barring states from needlessly imposing a law that specifies that a person must satisfy certain requirements or follow certain procedures or regulations in order to vote that are contrary to, or violate, or undermine the right or ability to vote and carry out the Constitutional process of elections. Laws requiring people to register to vote in advance of elections, mandating that they vote at their assigned polling places, providing proof of identity and residence are exactly the types of provisions and stipulations that the Elections Clause enforces and protects.

Thus, the ONE VOTE System, stands upon and makes declaration to the fact that the using of a centralized non-transparent black box, using mail-in ballots with nothing but a signature to validate the authenticity of the vote, the use of computers that now tabulate the vote and that are connected to the internet are all in violation of our Constitutional rights and the statutes of the Election Clause of the Constitution. Furthermore, all of these violations that are happening in Oregon is the cause of voter disenfranchisement on an unprecedented scale at the hands of the government and government officials.

We the People of OREGON, a Free and Independent Nation=State, make Declaration the we have the constitutional right to have our ballots counted accurately, securely, and transparently so that only lawfully cast votes determine the winners of each contested office and that the government and government officials have the duty, sworn by their oath of office and by the Articles of the Constitution to ensure that elections are held with a maximum degree of accuracy, integrity, SECURITY and confidence.

# As with our roads, schools, and so much more, the performance of OREGON's government is uniquely inept.

The true purpose of all Government is to promote the Welfare and to provide for the Protection and Security of the governed; and when any form or organization of government proves inadequate for, or subversive of this purpose, **it is the Right - it is the Duty** of the governed to abolish it.

The Sovereign Men and Women of the Free and Independent Nation=State of OREGON understand the Founders sought to make sure that, not only would the Federal government remain a republic, but that the states who were admitted to the Union would have to be republic as well.

The Guarantee Clause of the United States Constitution (Article IV, Section 4) requires that each state of the Union provide a Republic form of government: *The United States shall guarantee to every State in this Union a Republic Form of Government* and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence.

The Sovereign Men and Women of the Free and Independent Nation=State of OREGON, having affirmed by prior Resolutions that the current State of OREGON has failed to discharge its duty to the Sovereign Men and Women as a republic form of government, choosing instead to govern as a pure totalitarian democracy, are affirming that it is the right of free Sovereign Men and Women to replace the failed State of OREGON, through the re-establishment of a new state GOVERNMENT. A De Jure Government.
