# STATEMENT OF INTENT

The Sovereign Men and Women of the Free and Independent Nation=State of OREGON have decided to remedy the abuse of power by the government of OREGON by exercising their right to form a De Jure Government as provided for in United States Constitution Article IV Sections 3 and Section 4 and upheld in the US Supreme Court by the Supreme Court decision in 1901 (Downes v. Bidwell).

***“We are determined to live under a State Government in the Republic for the United States of America and under the Constitution for the United States” and under the Declaration of Independence, cir.1776. and the Declaration of Independence, cir. 2010, ratified on November 12<sup>th</sup>, 2022, states:***

***“Whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government...”***

***“When a long train of abuses and usurpations...” and acts to seize and hold the people’s power without legal authority and “...pursuing invariably the same Object evinces (that clearly demonstrates) a design to reduce them under absolute Despotism, IT IS THEIR RIGHT, IT IS THEIR DUTY, to throw off such Government, and to provide new Guards for their future security.”***

The history of the present Governor and Government of OREGON is a history of repeated injuries and usurpations, all having in direct object the establishment of a Tyranny over the Counties of OREGON and the FREE AND INDEPENDENT NATION=STATE OF OREGON.

## **Preamble of the Free and Independent Nation=State of OREGON Constitution states:**

We, the representatives of the undersigned Counties within the State of OREGON, a Free and Independent Nation=State, ***do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....***

## **First Amendment of the United States Constitution states:**

***“Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”***

## **Fourth Amendment of the United States Constitution states:**

***“The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.”***

# STATE OF OREGON DECLARATION OF TRUTH INVASION

The people of OREGON are suffering from a tyrannical state government which fails to provide a republic form of governance, enables and supports across its borders the invasion of the United States of America by illegal foreign nationals and protects vicious criminals who commit outrageous acts of violence upon the Sovereign Men and Women of America all caused by a government of and for a mono-party system led by a tyrannical pusillanimous dictator who openly defies Federal law.

## OREGON STATE VIOLATES:

### United States Constitution Article IV Section 4

*“The United States shall guarantee to every State in this Union a Republican Form of Government* and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence.”

### United States Constitution Article VI

“This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.”

### First Amendment, United States Constitution

“Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”

### Fourteenth Amendment, United States Constitution Section 3.

“No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution for the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.”

# DECLARATION OF INVASION

## **Violation of United States Constitution Article IV Section 4, Clause 2 “...and shall protect each of them against invasion;”**

Article IV, Section 4 is generally known as The Guarantee Clause. Together with the Equal Protection Clause of the fourteenth Amendment of the Constitution, these were intended to be more than an authorization for the federal government to protect states against foreign invasion or internal insurrection, a power already conferred elsewhere in the Constitution. An additional object of the Guarantee Clause was to prevent states from establishing monarchical or despotic governments that might establish a tyrannical form of government.

The amendment requires “state action” as a requisite for its successful request of the Union for assistance or intervention. This ability, as guaranteed by the Constitution, of a “state” participation, over recent decades has been substantially ignored, despised, rejected, and circumvented by the pusillanimous (Spineless, cowering, spiritless, cowardly, feeble, and lacking in courage), governor and governmental officials of the State of OREGON.

The prime example of the failure of our pusillanimous governor and governmental officials of the State of OREGON to prevent the invasion of our communities is revealed in the September 26<sup>th</sup> event that occurred in Portland in which violent extremists rallied to destroy areas of the Rose City. The refusal of the government officials, specifically the governor, state legislators and city officials, to evoke article IV, Section 4 of the Constitution in order to prevent destruction and damage to personal and private property, commercial businesses and protect the people of OREGON was refused and rejected. This event and others that followed showed a clear and obvious violation of the Constitutional rights of the people and a willful intent to bring harm and destruction to the people and property that was well within their ability to prevent. Their dereliction of duty and responsibilities allowed for subsequent invasion and incursions by violent extremists in rural communities and country sides which were endured as well by the People with the suffering and loss of lives, loss of property, the dislocation of families from their homes by mandated evacuations and in some cases the wholesale destruction of entire townships and villages.

Furthermore, the rejection of the pusillanimous governor and governmental officials of the State of OREGON to honor their oaths of office to protect the people and uphold the Constitution has created dissent and division between the branches of law enforcement, the PEOPLE and these corrupt state, county, and city officials. State Police and county sheriffs, deputized by the US Marshall, openly defied mandates from their officials to stand down, end their federal deputized status and in some cases to intervene where their jurisdiction prevented them from actually upholding the Law. When law enforcement officers were federally deputized in order to increase and enhance enforcement of the law and retain prisoners under federal charges, our corrupt and pusillanimous governor and governmental officials only objected, further revealing their failure and premeditated intent to allow destruction and injury to the People and to property throughout the state of OREGON.

US Attorney Billy Williams and Law enforcement leaders alike complained to these officials about how their lack of leadership was creating and fueling the violence. Williams, in an interview said, "Portlanders, and Oregonians in general, are sick of the boarded-up and dangerous conditions prevalent in downtown Portland due to a lack of leadership." Oregon State Police Superintendent Travis Hampton was openly critical of district attorneys who refused to prosecute offenders who were arrested in the morning, released by DA's and re-arrested again in the evening. Hampton's statements were examples of the growing feud between local law enforcement and the elected leaders and the residents to whom they are accountable.

America's Founders were concerned about invasion. It was mentioned four times in the Constitution:

**Article I, Section 8, Paragraph 15:** The Congress shall have the Power (to) provide for calling forth the Militia to execute the Laws of the Union, suppress Insurrections and repel Invasions.

**Article I, Section 9, Paragraph 2:** The Privilege of the Writ of Habeas Corpus shall not be suspended, unless in cases of Rebellion or Invasion, the public Safety may require it.

**Article I, Section 10, Paragraph 3:** No State shall, without the Consent of Congress, lay any Duty of Tonnage, keep Troops, or Ships of War in time of Peace, enter into any agreement or Compact with another State, or with a foreign Power, or engage in War, unless actually invaded, or in such imminent Danger as will not admit of delay.

**Article IV, Section 4, Paragraph 1:** The United States shall guarantee to every State in this Union a Republican Form of Government and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence.

We, The PEOPLE of OREGON, a Free and Independent Nation=State, have firsthand lived through our state being invaded by violent extremists – Enemies both foreign and domestic. We are living through the INVASION of massive amounts of illegal immigrants flooding our land which overwhelms our economic system, our schools, our medical facilities, and our work forces. Knowing that many are simply impoverished people who are only looking for a hope of a better life, that is unfortunately, not the case with all of them. The facts reveal that hundreds of foreign-born individuals have been convicted or implicated in terrorism-related crimes since September 11, 2001. It is a well-documented fact that hordes of terrorists are bypassing the screening process (2016 Analysis released by Attorney General Jeff Sessions and the Department of Justice list of 580 Terrorism and Terrorism-related convictions).

According to the Oregon Department of Corrections (DOC) Inmate Population Profile dated January 1, 2014, the DOC indicated there were 1,165 foreign nationals (criminal aliens) incarcerated in its prison system. It is important to remember that for nearly every criminal alien in the Oregon prison system, there is at least one victim. This report can't contain the pain, heartache, and loss that many have felt at the hands of an illegal alien criminal. The DOC reports that the prison population of alien prisoners has grown annually about 1,259 which is an annual increase of roughly 10.96% of the overall growth in criminal alien prisoners since 2008.

**Let us NOT Forget: *For nearly every criminal alien in the Oregon prison system, there is at least one victim. There are families suffering that daily struggle to deal with the pain, heartache and loss that they have suffered at the hands of an illegal alien criminal.***

The State of OREGON Governor and government officials, working alongside leaders of foreign governments that are averse to the United States of America, facilitate and encourage the flood of illegal foreign nationals into OREGON. The State of OREGON, in open defiance of Federal law, has declared itself a sanctuary for all persons illegally entering the state. This sanctuary status acts as a magnet for known criminals or terrorists who desire to harm Sovereign Men and Women of OREGON and of the United States. This status brings human trafficking and drug smuggling activities to OREGON, endangering the lives and safety of its Sovereign Men and Women.

The State of OREGON has failed to prevent this invasion, which is in direct violation of the Constitution for the United States Article IV Section 4, that guarantees protection from invasion.

To be sure, state and local government officials are ***actively engaged*** in the ***trafficking of human flesh and slavery*** with vicious criminal cartels who are trafficking hundreds of thousands of illegal foreign nationals across the borders reaping billions of dollars each year. This is openly promoted by state government officials and members of the state legislature who approve legislation encouraging what is now a multibillion-dollar slave industry.

The on-the-ground violence and lawlessness all along the borders of OREGON and of the United States caused by cartels and gangs is extensive, well documented, and persistent. It satisfies the definition of ***“actually invaded”*** and ***“invasion”*** under the Constitution for the United States.

Today, OREGON is in a state of free fall at all levels. This free fall has been orchestrated over the last 170 years by socialist and communist regimes and we're now nearing the end of their socialist/communist plan that clearly demonstrates a design to reduce United States Sovereign Men and Women living in OREGON under absolute Despotism. Today this plan has eliminated the three branches of government, created a mono-party legislature which has enabled and empowered the rise of a **pusillanimous** Governor turned dictator.

A **pusillanimous** Governor, a spineless governor who has shown a lack of courage and shrinking from their sworn oath and responsibilities for the benefit and well-being of the free and sovereign Men and Women of the Free and Independent Nation=State of Oregon. Whose character is thus marked by every act which may define a tyrant, is unfit to be the elected Governor of a free people. Likewise, the Elected, Appointed and Regional Officials of the State of OREGON including the many unlawful departments of the corporation government who have grossly usurped authority and actively and grievously committed atrocities against We the People, such as, but not limited to, the DEQ, the unconstitutional sheriffs, the Department of Health and Welfare, the Child Services Department, The Bureau of Land Management, and the state and federal Forestry Departments, the AMA, CDC, and FDA whose character is thus marked by every act which may define them are that of a tyrant, abusive, unconstitutional and their criminal and despicable acts as corrupt authorities, are unfit to be the Elected, Appointed and deemed Regional Officials of a free people.

Governors and Officials of the State of OREGON have exhibited evidence of Tyranny and Treason against the Sovereign Men and Women, Counties, Towns and Cities of the State of OREGON.

The history of the present **pusillanimous** Governor of OREGON, the past Globalist Governor of OREGON, and many other Officials of the various unlawful departments of the State and county governments of OREGON have historically and repeatedly caused injuries and usurpations upon the sovereign Men and Women of Oregon, revealing their corrupt agenda and ultimate goal of establishing an absolute tyrannical government over the State of OREGON are thus guilty of treason, a crime punishable by death. They are desperate to hide their complicity, and thus they systematically target, demonize, and even "suicide" all who threaten to expose their treachery and malfeasance.

We the sovereign Men and Women of the Free and Independent Nation=State of OREGON have Petitioned for Redress of Grievances in the most humble terms. A total of one hundred ninety Grievances were read at County Courthouse locations within the borders of OREGON State during the course of the year of 2023. Nor have we, the sovereign Men and Women of the Free and Independent Nation=State of OREGON, been wanting in attentions to our OREGON brethren, but our repeated Petitions have been answered only by repeated injury.

The State of OREGON is in default and does not have constitutional standing as a member state in the union of states called the United States of America. ***We the People*** as Sovereign Men and Women of the United States living in OREGON, a Free and Independent Nation=State, are following the process of West Virginia, that successfully restored the Virginia state government after the Wheeling Conventions of 1861.

We entreat the governor, state legislators, government officials and county officials to abide by a bloodless solution, wherein you cease all destructive activities, dissolve your unlawful and unconstitutional tyrannical rule and other illicit, illegal and unlawful structures and custodial instruments, return our land, our assets, and our De Jure government to We The People, then retire, withdrawing your influence in an orderly fashion, so the people of OREGON can once again pursue our God-given rights of Life, Liberty and the Pursuit of Happiness.

Let it be known to all the world that OREGON State and the Free and Independent Nation-State of OREGON are resolute in our posture and positions. We declare that we are not the properties, not the administrative state, not the province of any theocratic ruler, nor any monarch, nor foreign entity or government but is a FREE AND INDEPENDENT NATION=STATE in the REPUBLIC for the United States of America.

OREGONIANS stand united to follow the United States Constitution Article IV, Sections 3 and 4, to throw off the tyranny that has been foisted upon all people of the great state of OREGON.

We, the sovereign Men and Women of the Free and Independent Nation=State of Oregon and the sovereign Counties that lie within, united by our Declaration of Independence and the United States Constitution, declare that we are a sovereign State and “this Nation=STATE, under God, shall have a new birth of freedom and that government of the people, by the people, for the people, shall not perish from the earth.”

## ACTS OF INSURRECTION

The government of OREGON, the current socialist governor/dictator and mono-party system along with local officials are following a coordinated design with the intent to actively engage in “***Acts of Insurrection***” against the United States Constitution.

## ACTS OF SECESSION
