STATEMENT OF INTENT

The Sovereign Men and Women of the Free and Independent Nation=State of OREGON have decided to remedy the abuse of power by the government of OREGON by exercising their right to form a De Jure Government as provided for in United States Constitution Article IV Sections 3 and Section 4 and upheld in the US Supreme Court by the Supreme Court decision in 1901 (Downes v. Bidwell).

"We are determined to live under a State Government in the Republic for the United States of America and under the Constitution for the United States" and under the Declaration of Independence, cir. 1776. and the Declaration of Independence, cir. 2010, ratified on November 12th, 2022, states:

"Whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government..."

"When a long train of abuses and usurpations..." and acts to seize and hold the people's power without legal authority and "...pursuing invariably the same Object evinces (that clearly demonstrates) a design to reduce them under absolute Despotism, <u>IT IS THEIR</u>

<u>RIGHT, IT IS THEIR DUTY</u>, to throw off such Government, and to provide new Guards for their future security."

The history of the present Governor and Government of OREGON is a history of repeated injuries and usurpations, all having in direct object the establishment of a Tyranny over the Counties of OREGON and the FREE AND INDEPENDENT NATION=STATE OF OREGON.

Preamble of the Free and Independent Nation=State of OREGON Constitution states:

We, the representatives of the undersigned Counties within the State of OREGON, a Free and Independent Nation=State, do acknowledge and humbly invoke the favor of Almighty God for continued civil and religious liberty to ourselves and our posterity....

First Amendment of the United States Constitution states:

"Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

Fourth Amendment of the United States Constitution states:

"The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

Likewise, the Elected, Appointed and Regional Officials of the State of OREGON including the many unlawful departments of the corporation government who have grossly usurped authority and actively and grievously committed atrocities against We the People, such as, but not limited to, the DEQ, the unconstitutional sheriffs, the Department of Health and Welfare, the Child Services Department, The Bureau of Land Management, and the state and federal Forestry Departments, the AMA, CDC, and FDA whose character is thus marked by every act which may define them are that of a tyrant, abusive, unconstitutional and their criminal and despicable acts as corrupt authorities, are unfit to be the Elected, Appointed and deemed Regional Officials of a free people.

Governors and Officials of the State of OREGON have exhibited evidence of Tyranny and Treason against the Sovereign Men and Women, Counties, Towns and Cities of the State of OREGON.

The history of the present **pusillanimous** Governor of OREGON, the past Globalist Governor of OREGON, and these other Officials of the many unlawful departments of the State government of OREGON is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over the State of OREGON are guilty of treason, a crime punishable by death. They are desperate to hide their complicity, and thus they systematically target, demonize, and even "suicide" all who threaten to expose their treachery and malfeasance.

We the sovereign Men and Women of the Free and Independent Nation=State of OREGON have Petitioned for Redress of Grievances in the most humble terms. Reading a total of one hundred ninety Grievances at County Courthouse locations within the borders of OREGON State during the course of the year of 2023. Nor have we, the sovereign Men and Women of the Free and Independent Nation=State of OREGON, been wanting in attentions to our OREGON brethren, but our repeated Petitions have been answered only by repeated injury.

OREGON STATE VIOLATES:

United States Constitution Article IV Section 4

"The United States shall guarantee to every State in this Union a Republican Form of Government and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence."

United States Constitution Article VI

"This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding."

First Amendment, United States Constitution

But Congress may by a vote of two-thirds of each House, remove such disability."

A REPUBLIC

The State of OREGON is in constitutional default and does not have constitutional standing as a member state in the union of states called the United States of America. We the People as Sovereign Men and Women of the United States living in OREGON, a Free and Independent Nation=State, are following the process of West Virginia, which successfully restored the Virginia state government after the Wheeling Conventions of 1861. Congress admitted OREGON into the Compact of Statehood within the United States of America in 1859 because their 1857 Constitution, ratified for consideration, guaranteed a Republic form of government.

United States Constitution Article IV, Section 4.

Protection of States Guaranteed Republic Form of Government.

The OREGON Constitutional Convention of 1857

"In 1846 to 1848 OREGON was facing many issues for all those who chose to settle in the territory. There were territorial disputes between several nations over the political division of the Northwest that had competing territorial commercial aspirations in the region. Conflicts were developing into familiar daily issues. Debates over slavery, liquor laws and boundaries brought hard times to the region. The hard times prepared the public mind to accept any change which promised peace in the territory and allowed settlers to live their lives as they chose to. Peace with the Indian nations had been achieved largely from the work of a mountaineering preacher man named Jedidiah Smith and a humble, hardworking missionary who was forsaken by his denomination named Jason Lee. Five Indian nation Chieftain's had visions of a long-haired white man who carried the "Book of Heaven" coming to their tribes. His work later led these chiefs to travel east with an entourage of 300 braves to sign the first Indian treaty in the US. Lee is credited with establishing the first permanent mission settlement and school in the Willamette River Valley and later the first provincial government in the Northwest territory. Lee saw Oregon as the home of a future white civilization as early as 1837. His work was significant to Oregon eventually pursuing statehood."

The first constitutional documents enacted in Oregon pre-dated statehood. These were the <u>Organic Law of 1843</u> and the Organic Law of 1845, adopted to govern <u>Oregon Territory</u>. In 1857, leaders of the territory gathered at the <u>Oregon Constitutional Convention</u> and drafted the current constitution. Over half of the document's content was derived in part from the <u>Indiana constitution</u>. The constitution of 1857 included <u>a racial exclusion section</u> that excluded <u>African Americans</u> and <u>Chinese</u> from the state.

On November 9, 1857, Oregon voters approved its first constitution that then became effective upon statehood on February 14, 1859. The constitution was unchanged for the remainder of the 19th century, but has been amended numerous times since 1902 (see <u>List of Oregon ballot measures</u>). The changes have included the introduction of a <u>direct legislation system</u>, which enabled Oregon voters to propose and approve amendments both to the Constitution and to the <u>Oregon Revised Statutes</u>.

In 1905, a coalition of Oregon lawyers advocated for convening a <u>constitutional convention</u> the following year, and drafted plans for the selection of delegates. According to <u>The Oregonian</u>, Portland attorneys were "almost to a man, in favor of making the change". Dissenters included Portland attorneys <u>George W. Joseph</u>, who advised "leaving well enough alone", and <u>C. E. S. Wood</u>, who insisted that the recent passage of initiative and referendum system offered sufficient opportunity to amend the constitution as needed. Governor <u>George Earle Chamberlain</u> declined to take a position. [4]

In 1916, Oregonians voted to keep Section 6 of Article II of the constitution, which read "No <u>negro</u>, <u>Chinaman</u> or <u>mulatto</u> shall have the right of <u>suffrage</u>", even though it had been rendered void by the <u>Fifteenth Amendment to the United States Constitution</u>. [5][6] In 1927, Oregonians finally decided to remove this suffrage exclusion from their constitution.

It is important to note that our state Constitution is a living document. It has been amended many times since its adoption in 1857. One hundred and sixty-six years since its inception, the Beaver State continues to be a leader throughout the nation and the world. Innovative public policy is often crafted, analyzed, and debated by the Legislature with the collective input of the electorate. This sense of progress and purpose can also be found in the documents featured in this publication, as our nation and state continue to strive for a more perfect union. The framers of our Constitution envisioned a Republic that protected fundamental "freedoms" and "rights."

Over time, these freedoms and rights have evolved to embrace a more diverse and inclusive society. Our state Constitution provides such a framework. It is in that spirit of freedom the OREGON Legislature presents these important documents, which shape our collective philosophy and the vision for a government of the people.

OREGON has been operating as a Republic since 1857 and yet, now this state has become a totalitarian dictatorship lacking in all aspects of a republic as demanded by the 1787 United States Constitution. Congress admitted OREGON into the Compact of Statehood within the United States of America in 1859 because their 1857 Constitution, ratified for consideration, guaranteed a republic form of government. By their own admission now gone is that guarantee of a republic form of government by the State of OREGON.
